Section 1.10, Page 08, bid security of 2.50% of the total financial offer in the form of Bank Guarantee in favor of First Security Islami Bank Limited. The bid security should be valid for 8 (Eight) months after the date of bid opening.  Section 1.28, page 15 The performance security must be valid for at least 10 (Ten) months Section 1.29, page 16, Training proposal for training and course completion certificate for 15 (fifteen) trainee. Local training will be accommodate outside of Dhaka with all the expenses and will remain unchanged.
	Section 1.30, Page 16, The advance amount as the advance security must be valid for at least 10 (Ten) months.
